4. Approval of Minutes

5. Old Business

A. Second Street Historic District / Landmark Designations

Commissioner Carpenter stated that she would be willing to host a reception at her residence (similar to the reception she hosted last September), but, suggested that it may be more appropriate for a reception to be held in closer proximity to the Second Street neighborhood where invited residents could hear the details of how to apply for landmark or historic district designation for their property.

Through the course of the discussion regarding the reception, Commissioner Carpenter noted that her urban planner contact with the village of Oak Park, Illinois, may be willing to take part in that presentation.

Second Street Stroll

Chairperson Britton recalled that at last month's meeting a Second Street Stroll event was tentatively scheduled for either Saturday, October 15th or 22nd, 2016.

Commissioner Langhenry suggested an appropriate theme for the Second Street Stroll could focus on those properties that have, or have had, school teachers as residents.

Discussion ensued regarding which properties to include in the event and potential sources for actors to portray historical Second Street residents. Huntley High School drama students, Del Webb's Sun City residents and the McHenry County Historical Society were suggested as possible sources for actors, with the latter historical society potentially serving as a source for period costumes as well.

B. May 2016 – Look at Local History Month

Chairperson Britton recalled the Village Board Proclamation commemorating May as Historic Preservation Month was typically done on the first Village Board – Committee of the Whole meeting in May and this year that falls on Thursday, May 5th.

- In addition to the Proclamation a Pride in Preservation (PiP) presentation will include the two (2) PiP recipient-properties awarded in October, 2015 (Zimmerman Residence 11302 Grove and the McHenry County Tourism Bureau 11879 Main) and the two (2) properties scheduled to receive the PiP award at the April 19th Historic Preservation Commission meeting (Post and Thackwray Residences 11610 Main and 11012 Myrtle, respectively).
- Additionally, on Saturday, May 28, 2016 the Farmer's Market historic preservation booth will be staffed by the Huntley History Alliance.

Chairperson Britton noted that Vice Chair Oldham has produced labels and lanyards to be displayed on items within the Town Square Park including the commemorative bell and mortar memorial.

Chairperson Britton also noted that the Huntley Historical placemats will be distributed through the month of May to four local restaurants including Sal's Pizza, Sammy's Restaurant, The Village Inn and Papa G's.

Scavenger Hunt

A. Certificate of Appreciation Properties

Chairperson Britton noted that at last month's meeting Commissioner Marino had reviewed criteria he drafted for awarding the Certificate of Appreciation for businesses with historic displays.

Commissioner Marino stated that he had drafted a set of criteria for the awarding businesses with the Certificate of Appreciation for the restoration and maintenance of their property which included the following:

- i. Use/Reuse of architectural materials/elements
- ii. Accurate to original construction or specified time period
- iii. Historically appropriate signage
- iv. Historically-appropriate materials

Nomination of Certificate of Appreciation – Restoration and Historic Display Businesses

Certificate of Appreciation – Restoration Award

Commissioner Marino nominated the building that includes Sal's Pizza and Shampooch & Kitty and Commissioner Carpenter nominated Strode's Furniture.

Certificate of Appreciation – Historic Display

Commissioner Marino nominated Starbucks and Sal's Pizza.

Chairperson Britton noted that the schedule for presentation of the Certificate of Appreciation awards is at the Thursday, May 5th Village Board – Committee of the Whole meeting.

Meeting with Village Trustee Hoeft

Commissioners Marino and Carpenter recounted their meeting with Trustee Hoeft on Monday, February 22, 2016 at Commissioner Carpenter's residence. The meeting's discussion included reviewing with Trustee Hoeft the various historic preservation programs the Commission is focused on and it was noted that Trustee Hoeft expressed his interest in attending a future Historic Preservation Commission meeting.

Commissioner Carpenter noted that Trustee Hoeft was enthusiastic and excited about the prospect of a comprehensive survey of historic properties as well as the other historic preservation initiatives included within the 2016 Work Plan.

Illinois Association of Historic Preservation Commissions (IAHPC)

Chairperson Britton noted that the Welcome Letter from the IAHPC was included in the Historic Preservation 50 Commission's meeting packet and Commissioner Carpenter volunteered to contact the IAHPC chairman to determine the privileges available to the Historic Preservation Commission through the IAHPC membership.

Commissioner Carpenter also noted that she continues to research if the Art Institute of Chicago may be a source

for student interns available to assist with the implementation of a comprehensive survey of Huntley's historic properties.

McHenry County Joint Council of Historic Groups

Chairperson Britton reminded the Historic Preservation Commission of the McHenry County Joint Council of Historic Groups meeting scheduled for Wednesday evening, March 23, 2016 at the McHenry County Archives facility (15615 Nelson Road, Woodstock, IL), followed by a meeting at the Hartland Township offices (15813 Nelson Road, Woodstock, IL).
