As you probably know, Carl Tomaso, Huntley's Village Manager since 1997, passed away suddenly on June 25th. He is greatly missed by all and will always be remembered as a respected leader and a tireless advocate for the residents of Huntley. Our thoughts and prayers remain with Carl's family.

The Summer Road Construction Season continues! The McHenry County Algonquin Road Widening Project is well underway and the relocation of the Village's watermain is complete. Once this project is completed, Algonquin Road will be widened from Church Street to Annandale (the intersection of Route 47 and Algonquin Road will be completed with the widening of Route 47). Before the end of the year, traffic signals will be installed on Haligus Road at Reed Road and Haligus Road and Huntley-Dundee Road. Commercial developers are widening Route 47 from Del Webb Boulevard/Oak Creek Parkway to Kreutzer Road. In July, the 2008 Street Improvement Program was completed in the Woodcreek Subdivision, Janice Drive, Martin Street and Mill Street from Grove Street to Myrtle.

Economic Development continues to be a top priority of the Village Board. Wal-Mart held its ground breaking ceremony on July 9th and construction is underway. Construction of Outlot 6 next to Wal-Mart is moving along rapidly as you can see when traveling Route 47. Centegra just opened the Ambulatory Care Mall and anticipates the opening of the Health Bridge Fitness Center in the next few months. The Heritage Woods Assisted Living Facility as well as the KinderCare, located at Regency Square, are both under construction. You will notice at Route 47

and Reed Road that construction is moving along nicely on the American Community Bank and Staff is currently reviewing the building permit plans for a new Walgreen's at the northeast corner of this intersection.

In July, an Administrative Law Judge issued a Proposed Order to the ICC in favor of ComEd's preferred route of the overhead high tension line through the Village. The Village Board has directed Staff and Special Legal Counsel to continue opposition in order to protect the quality of life of Huntley's residents.

It's been a great Summer for Huntley's Farmers Market and if you haven't had the opportunity, I encourage you to go out and experience this local favorite. The Market is held each Saturday from 8 a.m. to Noon through September 27th on Coral Street.

On a final note, I am pleased to announce the appointment of David Johnson as our new Village Manager. Dave has done an outstanding job in the position of Assistant Village Manager in Huntley for eight years. I'm sure he will continue to provide quality leadership to the residents of the Village of Huntley in his new role as Village Manager. My congratulations to Dave and his family.

Wal-Mart Supercenter Breaks Ground

On July 9th, the Mayor and Trustees joined representatives from Tucker Development and Wal-Mart Corporation for the official groundbreaking ceremony of the Huntley Wal-Mart Supercenter.

Wal-Mart officials said they hoped to open the 176,400 square foot store by early Spring 2009. It is projected, the store will create approximately 350 jobs and will nearly double the Village's sales tax base.

The Huntley Wal-Mart Supercenter will feature 36 general merchandise departments, an expanded lawn and garden center, a full line of electronics, a large health and beauty aids department, and a pharmacy. In addition, there will be a vision center and one-hour photo lab.

The grocery area will include bakery, delicatessen, fresh

Centegra's Immediate Care Center is located at 10350 Haligus Road (Corner of Haligus and Algonquin Road).

The Centegra Health Center building is anchored by Centegra Immediate Care. Immediate care is for those minor emergencies (not life-threatening or multiple trauma) that require

professional medical attention when one's doctor is not in, after hours or if someone does not have a primary care physician.

Centegra's new Health Center building features immediate care, an imaging center, physician offices and lab services. Centegra's 120,000 square-foot Health Bridge Fitness Center focuses on wellness, fitness, preventive health and health education and is scheduled to be opened later this year.

TRANSPORTATION & INFRASTRUCTURE

Huntley Conducting Transit Study

In 2007, the Village was awarded a grant from the Regional Transportation Authority (RTA) to prepare a study for Transit Station Site Selection and Transit Oriented Development (TOD) guidelines. While it is anticipated that this process will take between 6-12 months, it is likely that an actual transit/ train station will not be built for many years. However, the Village believes that it is important to begin this long range planning process.

The Lakota Group and Civiltech Engineering were chosen as the consulting team for this project. The consultants are preparing an analysis of the two potential transit sites located along the Union Pacific rail line. One site is located just east of Coyne Station Road, and the second is

south of Kreutzer Road.

On August 25th, the Board of Trustees and members of the Planning Commission met for the first of several Transit Station Study workshops planned for the Huntley community. A large portion of this first workshop included review of both the Kreutzer Road and Coyne Station sites. Village Trustees and Plan Commissioners also participated in a visual preference survey in order to obtain a better idea of what will work best in Huntley.

In the next few months, a Community Workshop will be held in order to share the site selection analysis and to capture Village residents' vision of the two potential sites.

Once the transit station site is selected by

the Board of Trustees, the TOD guidelines will be prepared. These guidelines will ensure that future development of the area around the transit station will meet the community's vision, area constraints/opportunities and sound transit and development principles. To do this, an additional Community Workshop will be held to obtain input from residents regarding their vision of what this area should look like in the future.

The exact dates, times and location of the Community Workshops will be posted on the Village Website at www.huntley.il.us and shared with all media outlets.



Route 47 Improvements

Most residents have noticed Route 47 is bustling with summer construction projects. The projects range from road widenings that will accommodate new commercial development to a major sewer line project, which will extend services south of the tollway. While it may be inconvenient to commuters at the moment, the Village is excited about the future economic impacts of these important projects.

In conjunction with the commercial development occurring along Route 47 between Oak Creek Parkway and Kreutzer Road, the east side of Route 47 is currently being widened to provide an additional northbound lane from Oak Creek Parkway to Kreutzer Road. Northbound right turn lanes will be included at Huntley Crossings Drive, Powers Road, Regency Parkway and the Huntley Grove Commercial access.



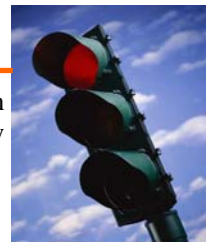
Southbound dual left turn lanes will be added at Huntley Crossings Drive and Regency Parkway. Traffic signals will be added at Huntley Crossings Drive and Regency Parkway.

Haligus Road Traffic Lights

Construction plans for the installation of traffic signals at the intersection of Haligus and Huntley-Dundee Road as well as Haligus and Reed Road have

been approved. The bid opening for this project was August 5th and the Village anticipates the installation of both signals to be completed by December 2008, with

landscape restoration targeted for early Spring.



Algonquin Road Widening

The McHenry County Department of Transportation continues work on the Phase 2 portion of Algonquin Road (Annandale to Route 47). The road will be five lanes upon completion and will improve the flow of east-west traffic through the Village. FUN FACT!

To construct Algonquin Road (Randall - Route 47), crews will put down **127,000 Square Yards** of concrete. If this was put down as a 5' wide sidewalk instead of a road, it would stretch from Huntley to Milwaukee!



Emerald Ash Borer Confirmed in Huntley

On Friday, July 25th, the Illinois Department of Agriculture (IDA) confirmed the presence of the Emerald Ash Borer (EAB) in the Village of Huntley. This is the first confirmed case of EAB in the Village.

The Huntley Public Works Department removed the infected tree, which was located on Oak Grove Drive in Sun City, on July 29th. A survey of all parkway trees will be conducted immediately to determine the number of Ash trees and locations. Once the tree survey has been completed, the Village will develop a plan for removing and replacing parkway trees.

The Village has been advised by the IDA that this process could take up to a decade or longer to accomplish. Infected ash trees located on private property will be the responsibility of property owners to remove. However, the Village must be notified of the removal so it can be documented to ensure proper removal procedures were followed.

The Emerald Ash Borer (EAB) is a small, metallic green, non-native invasive pest whose larvae feast on the trunks of ash trees thereby cutting off their ability to transport nutrients and ultimately causing the tree's decline. Ash trees can be infested with EAB for a few years before the tree begins to demonstrate any signs of infestation. Symptoms of EAB include canopy dieback, D-shaped exit holes, shoots sprouting from the tree trunks and S-shaped larval galleries underneath the bark.

Ash tree owners may ask about treatment options in order to avoid removing their trees; however, the only guaranteed method to control the Emerald Ash Borer is to remove the host tree(s). When considering usage of insecticidal control, one should weigh the value of the tree against the cost of treatment.

certainly supports tree owners' rights to determine for themselves whether a pesticide treatment is appropriate in their specific circumstance," Illinois Department of Agriculture Bureau Manager of Environmental Programs Warren Goetsch said.

"Tree owners are encouraged to thoroughly research the various treatment options currently available and carefully weigh the costs associated with the required repeated treatments. Please be advised, however, that treatment of an Ash tree will not guarantee that a specific tree will survive and you may eventually be required to remove it".

Under the provisions of the State of Illinois' Pest and Plant Disease Act, as well as the Nuisance Declaration issued in July 2006, the State has the authority to order the removal of any tree infested with the Emerald Ash Borer, regardless of whether it has been previously treated with a pesticide or not. The State has not exercised this authority to date, as all Emerald Ash Borer-related tree removals have been done on a voluntary basis.

Take Precautions Against



West Nile Virus

The warm months of summer and early fall bring with them an increase in the mosquito population and in the number of reported cases of West Nile Virus in Illinois communities.

West Nile is transmitted to humans and animals, particularly birds, by infected mosquitoes. The best way to control the spread of this potentially serious illness is by reducing the mosquito population through mosquito control operations at the community level and by eliminating standing water where mosquitoes breed.

You can reduce your personal risk by using insect repellent containing DEET when outdoors, especially during dawn, dusk and early evening hours.

The community approach to combating the disease is based on surveillance, monitoring and spraying to reduce mosquito population. This operation is performed by Clarke Mosquito Control Company, using only the most environmentally sensitive agents.

Noise Ordinance Adopted in Huntley

Until July, the Village has not had an official "Noise Ordinance" to address resident's noise concerns. The intent of the new ordinance is to ensure that Village neighborhoods remain a great place to live.

Highlights of the Noise Ordinance:

- Requires a permit for the outside use of sound-amplification devices.
- In general, prohibits unreasonably loud or raucous noise.
- Factors taken into considerations include; proximity of sound to sleeping facilities, the time of day or night the sound occurs, the duration of the sound, and whether the sound is recurrent, intermittent, or constant.
- **The following Quiet Times are established:**
 - » 10:00 p.m. through 7:00 a.m. Sunday–Thursday.
 - » 11:00 p.m. through 7:00 a.m. Friday & Saturday.

Residents Participate in National Night Out

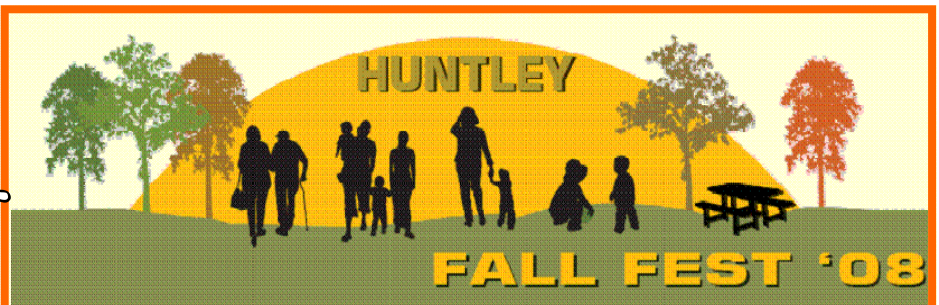


Nearly 50 Children from Georgian Place Subdivision participated in a National Night Out Bike Parade.

Wondering Where to Dispose of Leaves?



This is the perfect time to enjoy the beautiful fall foliage in Illinois. However, before long, most of those leaves will be on the ground and residents will be working diligently to clean up their yards.

Huntley's contract with MDC Environmental Services does provide for pick-up of yard waste (both grass clippings and leaves) from April 1st to November 30th. The yard waste must be placed in Kraft bags or specially marked cans. Del Webb's contract with Waste Management also provides for leaf pick-up through November 30th. However, Sun City residents must purchase yard waste stickers for \$2.25 (at Meadowview or Prairie Lodge). Some residents might want to 'leave' their leaves on the ground. By using a mulching mower, you can mulch the leaves and feed your lawn! You should inspect the lawn first and remove sticks and limbs, and be sure to wear goggles.

An Important Note About Burning: Although Huntley straddles 2 counties, the Village Board recently adopted the McHenry County Open Burning Ordinance to cover ALL property within the Village. Due to the relatively small size of residential lots in Huntley, leaf burning is now essentially illegal for the vast majority of homeowners within Village limits.
